

**RESOLUTION 2019-6  
MOUNT HOLLY FIRE DISTRICT No. 1**

**RESOLUTION AUTHORIZING ESTABLISHMENT OF AN OFFICIAL  
DEPOSITORY PURSUANT TO N.J.S.A. 17:9-9**

**WHEREAS**, the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington, State of New Jersey, has adopted a cash management plan pursuant to N.J.S.A. 40A:5-14; and

**WHEREAS**, said plan includes designation of an official public depository(ies) as defined in the "Governmental Unit Deposit Protection Act": N.J.S.A. 17:9-41, *et seq.*; and

**WHEREAS**, N.J.S.A. 17:9-9 mandates a public entity charged with the custody and control of public money, by resolution, to designate an official depository(ies); and

**WHEREAS**, T.D. Bank, N.A. qualifies as official public depositories pursuant to the "Governmental Unit Deposit Protection Act" (GUDPA) and is insured by the Federal Deposit Insurance Corporation (FDIC).

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington, State of New Jersey, that it designate T.D. Bank, N.A., High Street and Levis Drive, Mount Holly, New Jersey as its official public depository(ies) for fiscal year 2019; and

**BE IT FURTHER RESOLVED**, that the Director be authorized to execute an agreement for services for an on behalf of the Board and that the Clerk attest to same; and

**BE IT FURTHER RESOLVED**, that the hereinafter set forth Commissioners Jason Fajgier, Stefanie Haines, Joshua Brown, Richard McIlwee and Donald Pike, and Director Ryan Donnelly be designated as official signatories on all accounts; and

**BE IT FURTHER RESOLVED**, that pursuant to N.J.S.A. 40A: 14-89 all money to be disbursed by check, drafts, or warrants be signed by three (3) signatories or in such other manner or form as prescribed by the Board; and

**BE IT FURTHER RESOLVED**, that a copy of this Resolution be forwarded to the District Auditor for preparation of the 2019 compliance audit; and

**BE IT FURTHER RESOLVED**, that the within Resolution shall be effective immediately upon passage; and

**BE IT FURTHER RESOLVED**, that any resolution or part of a resolution inconsistent herewith are hereby repealed or otherwise revoked; and

**BE IT FURTHER RESOLVED**, that if any section, paragraph, sentence, clause or phrase in the Resolution is for any reason held or determined to be unconstitutional or invalid, same shall not affect the remainder of this Resolution; and

**BE IT FURTHER RESOLVED**, that notwithstanding anything set forth herein to the contrary, the Board shall be permitted to amend, modify, repeal or otherwise act as to those topics which are the subject of the Resolution provided said acts are consistent with public policy, Board bylaws, township ordinances, local, state and federal laws and rules and regulations promulgated thereunder; and

**BE IT FURTHER RESOLVED**, that an original signed, conformed and compared copy of this Resolution be accessible and maintained by the Board of Fire Commissioners of Fire District No.1 as an official Board record pursuant to and in accordance with the "Open Public Records Act", N.J.S.A. 47:1A-1 et seq. and the "Destruction of Public Records Law (1953)"; N.J.S.A. 47:3-8.1, *et seq.* as set forth by the State of New Jersey Municipal Agency Record Retention Schedule promulgated by the Division of Archives and Record Management.
