**RESOLUTION AUTHORIZING SERVICE CONTRACT FOR LAWN MAINTENANCE SERVICES**

**WHEREAS**, in order for the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington, State of New Jersey to fulfill its mandated charge of fire prevention, protection and suppression within the Township, it finds the maintenance of facilities owned and leased by it is a necessary incidental and implied duty; and,

**WHEREAS**, the Board is charged with conforming to the property maintenance provisions of the Code of the Township of Mount Holly; and,

**WHEREAS**, the Board has found, in the past, it is necessary to retain lawn maintenance services for this purpose; and,

**WHEREAS**, the Board finds and determines in anticipation of the growing season occurring in April, 2015 through November, 2015 that it will require such similar services; and,

**WHEREAS**, the Treasurer and Director of Fire Services has determined that past practice and anticipated needs for this service will exceed the informal quotation process; and, **WHEREAS**, the Director of Fire Service has received formal quotes for this service;

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington and State of New Jersey that it enter into a contract with Father Nature Landscaping, 1051 Oxmead Road, Westampton, New Jersey 08060 for lawn maintenance services pursuant to the terms and conditions set forth in a proposed contract attached hereto as Schedule A;

**BE IT FURTHER RESOLVED**, that the Director of Fire Services execute said contract for and on behalf of the Board and the Secretary attest thereto;


