## RESOLUTION FIXING THE SALARIES, WAGES, COMPENSATION AND BENEFITS FOR OFFICIALS AND EMPLOYEES OF THE BOARD OF FIRE COMMISSIONERS FOR FISCAL YEAR 2017

**BE IT FURTHER RESOLVED,** that the Board hereby authorizes payment of salaries, remuneration, allowances, expenses, education stipend, and other compensation and benefits provided for in any negotiated contract entered into between the Board and any employee; and

**BE IT FURTHER RESOLVED,** that the salary, wages and compensation set forth in this Resolution is the maximum compensation to be paid for various positions during 2017 and for such period or periods as this Resolution shall remain in effect; and

**BE IT FURTHER RESOLVED,** such maximum salaries, wages and compensation shall be paid for each of the positions indicated unless the Board, by Resolution, shall otherwise fix the salary, wages and compensation in which event such amount shall be paid; and

**BE IT FURTHER RESOLVED,** that all compensation authorized by this Resolution shall be paid commencing retroactive to January 1, 2017 through December 31, 2017; and

**BE IT FURTHER RESOLVED,** that if any section, paragraph, sentence, clause or phrase in this Resolution is for any reason held or determined to be unconstitutional or invalid or is in contradiction to any Collective Bargaining Agreement or other negotiated contract the same shall not affect the remainder of this Resolution; and

**BE IT FURTHER RESOLVED,** that any Resolution, or part of a Resolution inconsistent herewith are hereby repealed or otherwise revoked; and

**BE IT FURTHER RESOLVED,** that an original signed, conformed and compared copy of this Resolution be accessible and maintained as an official Board record pursuant to and in accordance with the "Open Public Records Act"; N.J.S.A. 47:1A-1, *et seq.* and the "Destruction of Public Records Law (1953)"; N.J.S.A. 47:3-8.1, *et seq.* as set forth by the State of New Jersey Municipal Agency Record Retention Schedule promulgated by the Division of Archives and Record Management.
