**RESOLUTION AUTHORIZING NOTICE OF PUBLIC MEETINGS PURSUANT
TO N.J.S.A. 10:4-18**

WHEREAS, N.J.S.A. 10:4-18 requires every public body to post and maintain posted throughout the year in a public place reserved for such or similar announcements a notice of its regularly scheduled meetings for the year; and

WHEREAS, the aforementioned statute requires that the notice of the annual schedule of regular meetings be forwarded to the newspapers designated by the Board to receive such notices pursuant to N.J.S.A. 10:4-8(d); and

WHEREAS, the annual regular meeting schedule shall contain the location of each meeting, to the extent it is known and the time and date of each meeting; and

WHEREAS, the Board of Fire Commissioners of Fire District No. 1 finds and determines that it shall continue to hold its regular monthly meeting on the first Wednesday of the month and work session meeting on the third Thursday of May, September, November, and January throughout fiscal year 2017.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington, State of New Jersey that all meetings for the fiscal year following the March 1, 2017 meeting be held at 7:30 p.m. at the Mount Holly Fire District Administration Office, 100 Garden Street, Mount Holly, New Jersey with the exception of the March 7, 2018 reorganization meeting which will be held at the Mount Holly Township Municipal Building, 23 Washington Street, Mount Holly, New Jersey; and

BE IT FURTHER RESOLVED, that a notice of the annual regular monthly meeting schedule inclusive of the date, time and place thereof be published in the Board's official newspaper, the Burlington County Times and forwarded to the Courier Post for its information; and

BE IT FURTHER RESOLVED, that a notice be forwarded to the Clerk of the Township of Mount Holly requesting said notice be posted and maintained throughout the fiscal year 2017 in a place within the Township Municipal Building designated by the Township for posting of such notices; and

BE IT FURTHER RESOLVED, that the annual regular and work session meeting schedules be posted at the Fire District Administration Office, Good Intent Fire Company, 100 Garden Street, Mount Holly, New Jersey; and Relief Fire Company, 17 Pine Street, Mount Holly, New Jersey; and

BE IT FURTHER RESOLVED, that subsequent to the above mentioned publication and postings, the annual regular meeting schedule is thereafter revised the Board shall publish and post such revisions in the same manner and means described above; and


