

**Resolution 2015-2
Mount Holly Fire District No.1**

RESOLUTION ESTABLISHING A TEMPORARY BUDGET

PURSUANT TO N.J.S.A. 40A:14-78.17

WHEREAS, the Board of Fire Commissioners of Fire District No.1, Township of Mount Holly, County of Burlington, State of New Jersey, have certain contracts, commitments or other payments that must be made prior to the adoption of the 2015 Budget; and

WHEREAS, N.J.S.A. 40A:14-78.17 provides that a Fire District may, by Resolution, adopt prior to January 15, a Temporary Budget to make Appropriations to provide for the period between the beginning of the fiscal year and the adoption of the Budget; and

WHEREAS, the total Appropriations permitted to be made in the Temporary Budget shall not exceed 14% of the total of the preceding fiscal year excluding Appropriations made for interest and debt redemption charges and Capital Improvements; and

WHEREAS, the Board finds it necessary to adopt a Temporary Budget for fiscal year 2015.

NOW THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington and State of New Jersey that a Temporary Budget for 2015 be adopted in the amount of \$82,219.64 ; and

BE IT FURTHER RESOLVED, that the Appropriations be designated to the following line items in the hereinafter set forth amounts:

BE IT FURTHER RESOLVED, that nothing contained herein shall relieve the Fire District from making Appropriations for all interest and debt redemption charges maturing during the fiscal year 2015 at any time prior to the date of the adoption of the Budget; and

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the District Auditor, Robert Inverso, for the purpose of making the appropriate adjustments in the Audit for the 2015 fiscal year; and

BE IT FURTHER RESOLVED, that the within Resolution shall be effective immediately upon passage; and

BE IT FURTHER RESOLVED, that any resolution or part of a resolution inconsistent herewith are hereby repealed or otherwise revoked; and

BE IT FURTHER RESOLVED, that if any section, paragraph, sentence, clause or phrase in this Resolution is for any reason held or determined to be unconstitutional or invalid same shall not affect the remainder of this Resolution; and

BE IT FURTHER RESOLVED, that notwithstanding anything set forth herein to the contrary the Board shall be permitted to amend, modify, repeal or otherwise act as to those topics which are that subject of this Resolution provided said acts are consistent with public policy, Board bylaws, Township ordinances, local, state and federal laws and rules and regulations promulgated thereunder; and

BE IT FURTHER RESOLVED, that an original signed, conformed and compared copy of this Resolution be accessible and maintained as an official Board record pursuant to and in accordance with the "Open Public Records Act";


