## RESOLUTION AUTHORIZING A CONTRACT FOR LEGAL SERVICES

WHEREAS, the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington, State of New Jersey as a public body duly organized under the laws of the State of New Jersey, requires the services of legal counsel, specifically relating to municipal finance, to advise the Board in matters pertaining to municipal finance, local finance applications, and to provide representation before any authority requiring such; and

WHEREAS, the Board is permitted under the law to retain the services of legal counsel; and

**WHEREAS**, the Local Public Contracts Law, specifically N.J.S.A. 40A:11-5(1)(a)(i), requires that professional services awarded without competitive bid be publicly advertised; and

WHEREAS, the term of the Contract is for one (1) year or less.

**WHEREAS,** Treasurer of the Board of Fire Commissioners has determined that the value of the services to be performed will not exceed \$10,000; and

WHEREAS, the Board finds and determines that Charles Anthony Solimine of the firm Wilentz, Goldman & Spitzer, P.A. meets the needs of the District for legal services and that the appointment under a non-bid process is in the District's best interest.

**NOW, THERFORE BE IT RESOLVED,** by the Board of Fire Commissioners, Fire District No.1, Township of Mount Holly, County of Burlington, State of New Jersey, that it retain the services of Charles Anthony Solimine of the firm Wilentz, Goldman & Spitzer, P.A., 90 Woodbridge Center Drive Suite 900, Woodbridge, NJ not to exceed the above set forth amount; and

**BE IT FURTHER RESOLVED**, that the contract award is made without competitive bidding as a "Professional Service" in accordance with the Local Public Contracts Law, specifically N.J.S.A. 40A:11-5(1)(a)(i), because it is for services performed by persons authorized by law to practice a recognized profession; and

**BE IT FURTHER RESOLVED,** that a copy of this Resolution, as well as the Agreement for Services, be maintained at the District office and readily available to the public; and

**BE IT FURTHER RESOLVED,** that a notice in the form attached hereto be published in the District's official newspaper, The Burlington County Times; and

**BE IT FURTHER RESOLVED,** that the Board Chairman and/or Director of Fire Services be authorized to execute any and all documents necessary to effectuate the intent and purposes of this Resolution and the Clerk attest thereto; and

**BE IT FURTHER RESOLVED,** that the within Resolution shall be effective immediately upon passage; and

**BE IT FURTHER RESOLVED,** that any resolution or part of a resolution inconsistent herewith is hereby repealed or otherwise revoked; and

**BE IT FURTHER RESOLVED,** that if any section, paragraph, sentence, clause or phrase in this Resolution is for any reason held or determined to be unconstitutional or invalid, same shall not affect the remainder of this Resolution; and

**BE IT FURTHER RESOLVED,** that notwithstanding anything set forth herein to the contrary, the Board shall be permitted to amend, modify, repeal or otherwise act as to those topics which are the subject of this Resolution provided said acts are consistent with public policy, Board bylaws, township ordinances, local, state and federal laws and rules and regulations promulgated thereunder; and

**BE IT FURTHER RESOLVED**, that an original signed, conformed and compared copy of this Resolution be accessible and maintained as an official Board record pursuant to and in accordance with the "Open Public Records Act"; N.J.S.A. 47:1A-1, *et seq.* and the "Destruction of Public Records Law (1953)"; N.J.S.A. 47:3-8.1, *et seq.* as set forth by the State of New Jersey Municipal Agency Record Retention Schedule promulgated by the Division of Archives and Record Management.
