

**RESOLUTION 2020-26  
MOUNT HOLLY FIRE DISTRICT No.1**

**RESOLUTION APPOINTING A FIRE OFFICIAL  
PURSUANT TO N.J.A.C. 5:71-3.2**

**WHEREAS**, the “Uniform Fire Safety Act”, N.J.S.A. 52:27D-192 et seq. was enacted with its purpose and intent to ensure that lives and property of the State’s citizens are protected by a uniform minimum fire safety code; and

**WHEREAS**, pursuant to the “Act” and in accordance with the “Administrative Procedure Act”, P.L. 1968, C.410 (N.J.S.A. 52:14B-1 et seq.) Rules and Regulations have been promulgated and which have been embodied in the Uniform Fire Code, N.J.A.C. 5:70-1et seq.; and

**WHEREAS**, pursuant to said “Act” and “Code”, the Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington, State of New Jersey, have been designated the local enforcing agency with the mandated charge of enforcement of the “Act” and “Code”; and

**WHEREAS**, the Board of Fire Commissioners of the Fire District No. 1, Township of Mount Holly, has created the Bureau of Fire Prevention which is directly controlled and supervised by the Board of Fire Commissioners for the purposes and intent of enforcing said “Act” and “Code”; and

**WHEREAS**, pursuant to N.J.S.A. 40A:14-81.1, The Board has created the paid position of Fire Official; and

**WHEREAS**, since its inception, the Board has appointed a Fire Official pursuant to N.J.A.C. 5:71-3.2 and N.J.S.A. 11A:1-1 et seq. to serve as the Chief Administrator of the Bureau of Fire Prevention, to establish the day-to-day operating routines of the Bureau of Fire Prevention and coordinate the activities of the fire inspectors and other staff; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington, State of New Jersey that it appoint George Gaskill as Fire Official to administer the Bureau of Fire Prevention; and

**BE IT FURTHER RESOLVED**, that said appointment shall be effective commencing January 1, 2021 and shall continue until further action of the Board or December 31, 2021 whichever is sooner; and

**BE IT FURTHER RESOLVED**, that the duties of the Fire Official shall include those as set forth in N.J.A.C. 5:71-3.3 and the employment responsibilities description developed by the Board after consulting the requirements under N.J.S.A. 11A:1-1 et seq. and the Rules and Regulations promulgated thereunder and as directed by the Board and/or its designee; and

**BE IT FURTHER RESOLVED**, that a copy of this Resolution be forwarded to the New Jersey Department of Community Affairs, Division of Fire Safety for its records; and

**BE IT FURTHER RESOLVED**, that a signed, conformed and compared copy of this Resolution be maintained by the Board of Fire Commissioners of Fire District No.1 as an official Board record pursuant to and in accordance with the "Open Public Records Act", N.J.S.A. 47:1A-1 et seq. and pursuant to and in accordance with the State of New Jersey Municipal Agencies Record Retention Schedule promulgated by the Division of Archives and Record Management.


