**RESOLUTION AUTHORIZING SALARIES FOR
THE BUREAU OF FIRE PREVENTION**

WHEREAS, the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington, State of New Jersey has created paid positions to administer and enforce the Uniform Fire Safety Act and Uniform Fire Code; and

WHEREAS, pursuant Board policies and N.J.S.A. 11A:1-1 et seq. the Board made appointments to the positions of Fire Official and Fire Inspector (Fire Prevention Specialist); and

WHEREAS, the Board finds and determines annually the appropriate amount of compensation for service performed in the respective positions.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington, State of New Jersey that the following salaries be fixed for the designated positions:

- A. Fire Official - \$16,000 per annum
- B. Fire Inspector (Fire Prevention Specialist) – up to \$16.00 per hour

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the New Jersey Department of Community Affairs, Division of Fire Safety for its records; and

BE IT FURTHER RESOLVED, that any Resolution or action of the Board pertaining to salaries of the hereinabove designated positions are hereby rendered void; and

BE IT FURTHER RESOLVED, that a copy of this Salary Resolution be forwarded to the District auditor for his information in preparation of the Annual Audit; and

BE IT FURTHER RESOLVED, that a signed, conformed and compared copy of this Resolution be maintained by the Board of Fire Commissioners of Fire District No.1 as an official Board record pursuant to and in accordance with the “Open Public Records Act”, N.J.S.A. 47:1A-1 et seq. and pursuant to and in accordance with the State of New Jersey Municipal Agencies Record Retention Schedule promulgated by the Division of Archives and Record Management.
