- 2. That **Joshua Brown**, Board Treasurer, is hereby designated as Supervisor of the Certifying Officer for Mount Holly Fire District No.1 for the Public Employee Retirement System (PERS), the Police and Fire Retirement System (PFRS), and the Defined Contribution Retirement Program (DCRP) of the State of New Jersey, to serve in that position for and during the calendar year of 2021.

BE IT FURTHER RESOLVED, that a signed, conformed and compared copy of this Resolution be maintained by the Board of Fire Commissioners of Fire District No.1 as an official Board record pursuant to and in accordance with the "Open Public Records Act", N.J.S.A. 47:1A-1 et seq. and pursuant to and in accordance with the State of New Jersey Municipal Agencies Record Retention Schedule promulgated by the Division of Archives and Record Management.
