- **BE IT FURTHER RESOLVED**, that a notice be forwarded to the Clerk of the Township of Mount Holly requesting said notice be posted and maintained throughout the fiscal year 2023 in a place within the Township Municipal Building designated by the Township for posting of such notices; and
- **BE IT FURTHER RESOLVED**, that the annual regular meeting schedule be posted at the Fire District Administration Office, Relief Fire Station, 17 Pine Street, Mount Holly, New Jersey; and Good Intent Fire Station, 100 Garden Street, Mount Holly, New Jersey; Mount Holly Township Municipal Building, 23 Washington Street, Mount Holly, New Jersey; and on the official District website, www.mounthollyfire.org; and
- **BE IT FURTHER RESOLVED,** that subsequent to the above-mentioned publication and postings, the annual regular meeting schedule is thereafter revised the Board shall publish and post such revisions in the same manner and means described above; and
- **BE IT FURTHER RESOLVED**, that a signed, conformed and compared copy of this Resolution be maintained by the Board of Fire Commissioners of Fire District No.1 as an official Board record pursuant to and in accordance with the "Open Public Records Act", N.J.S.A. 47:1A-1 et seq. and

pursuant to and in accordance with the State of New Jersey Municipal Agencies Record Retention Schedule promulgated by the Division of Archives and Record Management.
