**WHEREAS**, the Board is likewise required to post various notices of the above set forth activities, events and functions in public places normally reserved for same.

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington, State of New Jersey that the Burlington County Times be and the same is hereby designated as the official newspaper for publications of all required notices for the fiscal year 2023; and

**BE IT FURTHER RESOLVED,** that the Courier Post be and the same is hereby designated as the newspaper to receive for information purposes only all meeting notices of the Board of Fire Commissioners of Fire District No. 1 during fiscal year 2023; and

**BE IT FURTHER RESOLVED,** that the bulletin board at the Mount Holly Township Municipal Building located at 23 Washington Street, Mount Holly, New Jersey is hereby designated as the official place where all required official notices are to be posted; and

**BE IT FURTHER RESOLVED,** that the Township Clerk of the Township of Mount Holly shall be the individual designated by the Board to receive all required public notices; and

**BE IT FURTHER RESOLVED**, that all required public notices be also posted at the Fire District Administration Office, Good Intent Fire Company, 100 Garden Street, Mount Holly, New Jersey; and Relief Fire Company, 17 Pine Street, Mount Holly, New Jersey; and on the District official website, <a href="https://www.mounthollyfire.org">www.mounthollyfire.org</a>; and

**BE IT FURTHER RESOLVED,** that the within Resolution shall be effective immediately upon passage; and

**BE IT FURTHER RESOLVED,** that any resolution or part of a resolution inconsistent herewith are hereby repealed or otherwise revoked; and

**BE IT FURTHER RESOLVED,** that if any section, paragraph, sentence, clause or phrase in the Resolution is for any reason held or determined to be unconstitutional or invalid, same shall not affect the remainder of this Resolution; and

**BE IT FURTHER RESOLVED**, that notwithstanding anything set forth herein to the contrary, the Board shall be permitted to amend, modify, repeal or otherwise act as to those topics which are the subject of the Resolution provided said acts are consistent with public policy, Board bylaws, township ordinances, local, state and federal laws and rules and regulations promulgated thereunder; and

**BE IT FURTHER RESOLVED**, that an original signed, conformed and compared copy of this Resolution be accessible and maintained by the Board of Fire Commissioners of Fire District No.1 as an official Board record pursuant to and in accordance with the "Open Public Records Act", N.J.S.A. 47:1A-1 et seq. and the "Destruction of Public Records Law (1953)"; N.J.S.A. 47:3-8.1, *et seq.* as set forth by the State of New Jersey Municipal Agency Record Retention Schedule promulgated by the Division of Archives and Record Management.
