## RESOLUTION 2022-3 MOUNT HOLLY FIRE DISTRICT No. 1

# RESOLUTION AUTHORIZING JOB TITLE OF FIRE OFFICIAL/FIRE PROTECTION SUBCODE OFFICIAL

**WHEREAS,** in order for the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington, State of New Jersey to fulfill its mandated charge of fire prevention, protection and suppression within the Township, it finds the need to authorize the use of the job title, Fire Official/Fire Protection Subcode Official; and,

**WHEREAS,** N.J.S.A. 40A:14-81.1 provides that a Fire District may establish paid positions within the Fire District by resolution, as shall be determined by the Board of Fire Commissioners for the purposes of the Fire District; and,

WHEREAS, the Board of Fire Commissioners has determined that the establishment and creation of the paid position of Fire Official/Fire Protection Subcode Official is required for the purposes of the Fire District; and,

**NOW THEREFORE, BE IT RESOLVED,** by the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington, State of New Jersey that:

- (1) The position of Fire Official/Fire Protection Subcode Official is hereby established.
- (2) The requirements, duties, and powers of said position are as described in the "Fire Official/Fire Protection Subcode Official" Civil Service Commission job description.
- (3) This resolution shall take effect following final adoption and publication pursuant to New Jersey statutory law.
- **BE IT FURTHER RESOLVED,** that any resolution or part of a resolution inconsistent herewith are hereby repealed or otherwise revoked; and
- **BE IT FURTHER RESOLVED,** that if any section, paragraph, sentence, clause or phrase in the Resolution is for any reason held or determined to be unconstitutional or invalid, same shall not affect the remainder of this Resolution; and
- **BE IT FURTHER RESOLVED,** that notwithstanding anything set forth herein to the contrary, the Board shall be permitted to amend, modify, repeal or otherwise act as to those topics which are the subject of the Resolution provided said acts are consistent with public policy, Board bylaws, township ordinances, local, state and federal laws and rules and regulations promulgated thereunder; and
- **BE IT FURTHER RESOLVED,** that an original signed, conformed and compared copy of this Resolution be accessible and maintained by the Board of Fire Commissioners of Fire District No.1 as an official Board record pursuant to and in accordance with the "Open Public Records Act", N.J.S.A. 47:1A-1 et seq. and the "Destruction of Public Records Law (1953)"; N.J.S.A. 47:3-8.1, *et seq.* as set

forth by the State of New Jersey Municipal Agency Record Retention Schedule promulgated by the Division of Archives and Record Management.
