

**RESOLUTION 2022-6  
MOUNT HOLLY FIRE DISTRICT No. 1**

**RESOLUTION AMENDING CHAPTER 128, "FIRE PREVENTION CODE"  
OF THE TOWNSHIP OF MOUNT HOLLY**

**WHEREAS**, in order for the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington, State of New Jersey to fulfill its mandated charge of fire prevention, protection and suppression within the Township, it finds the need to amend Chapter 128 of the Township Code of Mount Holly Township, "Fire Prevention Code"; and,

**WHEREAS**, the Fire Official has recommended modifications to Chapter 128 to update the fee schedule for Certificate of Smoke Detector and Carbon Monoxide Alarm and Portable Fire Extinguisher Compliance; and,

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington, State of New Jersey as follows:

Chapter 128, the Fire Prevention Code of the Township of Mount Holly is hereby amended as follows:

§ 128-8 Permits and Fees

D. The fee for ~~a smoke detector inspection~~ an inspection for Certificate of Smoke Detector and Carbon Monoxide Alarm and Portable Fire Extinguisher Compliance for the change of ownership for one- and two-family structures shall be ~~\$25~~ \$85 for initial inspection per dwelling unit and common area and \$50 for each subsequent reinspection until compliance.

**BE IT FURTHER RESOLVED**, that any resolution or part of a resolution inconsistent herewith are hereby repealed or otherwise revoked; and

**BE IT FURTHER RESOLVED**, that if any section, paragraph, sentence, clause or phrase in the Resolution is for any reason held or determined to be unconstitutional or invalid, same shall not affect the remainder of this Resolution; and

**BE IT FURTHER RESOLVED**, that notwithstanding anything set forth herein to the contrary, the Board shall be permitted to amend, modify, repeal or otherwise act as to those topics which are the subject of the Resolution provided said acts are consistent with public policy, Board bylaws, township ordinances, local, state and federal laws and rules and regulations promulgated thereunder; and

**BE IT FURTHER RESOLVED**, that an original signed, conformed and compared copy of this Resolution be accessible and maintained by the Board of Fire Commissioners of Fire District No.1 as an official Board record pursuant to and in accordance with the "Open Public Records Act", N.J.S.A. 47:1A-1 et seq. and the "Destruction of Public Records Law (1953)"; N.J.S.A. 47:3-8.1, *et seq.* as set forth by the State of New Jersey Municipal Agency Record Retention Schedule promulgated by the Division of Archives and Record Management.
