**RESOLUTION BY THE MOUNT HOLLY BOARD OF FIRE
COMMISSIONERS OF THE MOUNT HOLLY FIRE
DISTRICT #1 RECOGNIZING PRIDE MONTH FOR THE
MONTH OF JUNE**

WHEREAS, the Mount Holly Fire District #1, would like to recognize the month of June as "PRIDE MONTH"

WHEREAS, the Mount Holly Fire District #1 desires to foster increased awareness in our community; and,

WHEREAS, the Mount Holly Fire District #1 wants this resolution to express the support for the rights, freedoms and equal treatments of lesbian, gay, bisexual, transgender and queer LGBTQIA+ individuals. These are human rights and protected by laws of the United States and International Treaties. Additionally, the resolution encourages the celebration of LGBTQIA+ Pride month in June, and reaffirms our commitment to ensure equity, dignity and inclusion both in life, the workplace and our communities.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington, State of New Jersey, that the public body has determined:

1. The Mount Holly Fire District #1, hereby recognizes the Month of June as PRIDE MONTH.

BE IT FURTHER RESOLVED, that the within Resolution shall be effective immediately upon passage; and

BE IT FURTHER RESOLVED that any resolution or part of a resolution inconsistent herewith, is hereby repealed or otherwise revoked; and

BE IT FURTHER RESOLVED, that if any section, paragraph, sentence, clause or phrase in this Resolution is for any reason held or determined to be unconstitutional or invalid, same shall not affect the remainder of this Resolution; and

BE IT FURTHER RESOLVED, that an original signed, conformed and compared copy of this Resolution be accessible and maintained as an official Board record pursuant to and in accordance with the "Open Public Records Act"; N.J.S.A. 47:1A-1, *et seq.* and the "Destruction of

Public Records Law (1953)"; N.J.S.A. 47:3-8.1, *et seq.* as set forth by the State of New Jersey Municipal Agency Record Retention Schedule promulgated by the Division of Archives and Record Management.

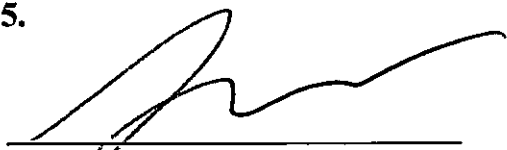
