## RESOLUTION AUTHORIZING THE THE LEASE/PURCHASE OF 2025 FORD EXPLORER SUVs

WHEREAS, the Fire District has determined that the lease/purchase of two (2) 2025 Ford Explorer SUVs (the "Vehicles"), as further described in the specifications for those Vehicles attached hereto as Exhibit A, is in the best interests for the safety and welfare of the residents that the District services; and

WHEREAS, the District has appropriated general funds for the purchasing of said equipment and services; and

WHEREAS, the District received the Proposal (the "Proposal") attached hereto as Exhibit B for the lease/purchase of the Vehicles and has determined that it is in the best interest for the safety and welfare of the residents that the District services to enter in the three year lease/purchase for the total price of Ninety Two Thousand, Eight Hundred and Fifty Dollars and (\$92,850), pursuant to the payment terms in the Proposal; and

WHEREAS, the contract is awarded without advertising for bidding or competitive bidding as a "contract for goods and services entered into on behalf of the State" of New Jersey by the Division of Purchase and Property in the Department of the Treasury, in accordance with Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq, and N.J.S.A. 40A:11-12, because the Proposal was received at a price, and from a vendor, approved by the State of New Jersey, as set forth more specifically in the attachments hereto; and

WHEREAS, the Fire District has determined that it is in the best interests of the Fire District that such equipment and services be paid for over a three-year period, as set out in the attached Proposal.

**NOW THEREFORE, be it RESOLVED,** by the Commissioners of the Fire District No. 1 in the Township of Mount Holly, County of Burlington, at a duly-authorized and noticed public meeting held on August 6, 2025 as follows:

- 1. The Commissioners hereby approve the purchase of the Vehicles at the authorized State of New Jersey contract price, for a total expenditure for both vehicles of \$92,850 in three annual payments of \$33,445 per year.
- 2. The Commissioners hereby authorize the Fire Director, or their designee, to take all appropriate action to complete such purchases.

**BE IT FURTHER RESOLVED**, that the within Resolution shall be effective immediately upon passage; and

**BE IT FURTHER RESOLVED** that any resolution or part of a resolution inconsistent herewith is hereby repealed or otherwise revoked; and

**BE IT FURTHER RESOLVED,** that if any section, paragraph, sentence, clause or phrase in this Resolution is for any reason held or determined to be unconstitutional or invalid, same shall not affect the remainder of this Resolution; and

**BE IT FURTHER RESOLVED,** that an original signed, conformed and compared copy of this Resolution be accessible and maintained as an official Board record pursuant to and in accordance with the "Open Public Records Act"; N.J.S.A. 47:lA-l, *et seg.* and the "Destruction of

Public Records Law (1953)"; N.J.S.A. 47:3-8.1, *et seq.* as set forth by the State of New Jersey Municipal Agency Record Retention Schedule promulgated by the Division of Archives and Record Management.
