

**RESOLUTION BY THE MOUNT HOLLY BOARD OF FIRE
COMMISSIONERS OF THE MOUNT HOLLY FIRE
DISTRICT #1 IMPLEMENTING A VOLUNTEER INCENTIVE
PROGRAM AND ADOPTING A VOLUNTEER INCENTIVE
PROGRAM POLICY**

WHEREAS, the Mount Holly Fire District #1, similar to many volunteer fire organizations around the country, has found it increasingly difficult to find and attract volunteer firefighters; and

WHEREAS, the Mount Holly Fire District #1 desires to foster increased participation and volunteerism within the Mount Holly Fire District #1; and,

WHEREAS, the Mount Holly Fire District #1 believes that one such opportunity is to provide incentives to provide financial incentives to volunteers consistent with FEMA SAFER guidelines; and,

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Fire District No. 1, Township of Mount Holly, County of Burlington, State of New Jersey, that the public body has determined:

1. The Mount Holly Fire District #1, hereby establishes a Volunteer Incentive Program;
2. The Volunteer Incentive Program will be subject to the Policy attached hereto as Exhibit A.

BE IT FURTHER RESOLVED, that the within Resolution shall be effective immediately upon passage; and

BE IT FURTHER RESOLVED that any resolution or part of a resolution inconsistent herewith is hereby repealed or otherwise revoked; and

BE IT FURTHER RESOLVED, that if any section, paragraph, sentence, clause or phrase in this Resolution is for any reason held or determined to be unconstitutional or invalid, same shall not affect the remainder of this Resolution; and

BE IT FURTHER RESOLVED, that an original signed, conformed and compared copy of this Resolution be accessible and maintained as an official Board record pursuant to and in accordance with the "Open Public Records Act"; N.J.S.A. 47:1A-1, *et seq.* and the "Destruction of

Public Records Law (1953)"; N.J.S.A. 47:3-8.1, *et seq.* as set forth by the State of New Jersey Municipal Agency Record Retention Schedule promulgated by the Division of Archives and Record Management.
